The Commission on Higher Education, in partnership with the Lyceum of the Philippines University-Batangas and the University of Alicante in Spain, will be having a one-year project entitled <u>Sustainable and Innovative Knowledge Application for Tourism</u> (SIKAT) Project under the International Continuing Professional Education (ICPE) Grants of CHED.

The SIKAT project is focused on improving and updating the curriculum needs of the Tourism sector, plus six (6) new topics taking into account the new challenges for local universities in a post-confinement scenario. Building the future of the next generation through the shared expertise of faculty members with strong institutional support would transform the lives of the families of the students when they are already serving the community as committed and dedicated professionals and workforce of the country.

### Main objectives of the project are:

- To provide the labour market & economy with high level skills required to enhance sustainable tourism through modernizing curricula, research and training offer in 85 Philippines HEIs; and
- To strengthen inter-institutional cooperation among Higher Education Institutions (HEIs), industry, and government in the Philippines, and foster innovation and knowledge transfer and policy support actions.

SIKAT will train 170 academic staff from 85 HEIs(5 institutions per region). During Phase 1 of the project, we already trained 102 scholars and we are still in need of 68 scholars for Phase 2.
