



Provide a maximum of five keywords (Keywords should include: Discipline of the study, concepts investigated, and methods).

Authors of accepted abstracts for presentation will be notified by May 23 and will be asked to confirm their attendance to the event within 48 hours. Failure to do the same will be tantamount to forfeiture of the chance to present.

Once participation is confirmed, the event credentials (Zoom link and other event details & reminders) will be sent to the registered email address. Please note that the event can only accommodate up to 300 participants, including the presenters.
