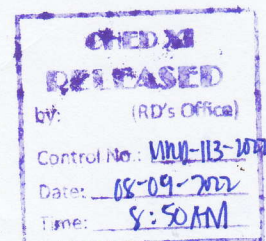
SUBJECT : **PARTICIPATION IN THE CONDUCT OF FOCUS GROUP

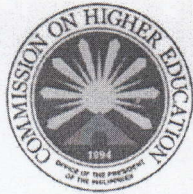

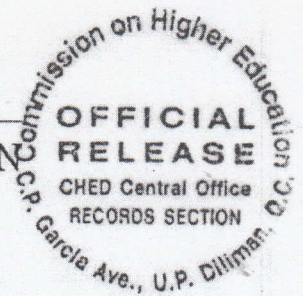
