6. Reconciliation of Accounts/Records.

The Accountants and Project Implementers (Lead) of SUCs' HEDF-funded projects are invited to join the important activity. Private Non-Stock HEIs that may be interested to apply for HEDF-funded projects are invited to attend the event.

The Commission shall provide the meals (AM Snacks, Lunch, and PM Snacks) during the workshop. Travel, accommodation, and other expenses should be shouldered by the respective institution.
